Customs clearance for machines and production lines in Netherlands is a critical process in the industrial sector, involving the documentation and regulatory compliance necessary for importing and exporting machinery in Netherlands.

What are the laws & regulations on energy storage in the Netherlands?

No specific laws & regulations: In the Netherlands, energy storage is not described in Dutch laws and regulations as a specific item. Standard requirements: It has to meet standard requirements for production and consumption and some specific technologies that are part of the energy storage system must comply with standardisation.

Do I need to declare goods to Dutch customs?

You must declare goods to Dutch Customs if you import these goods from a country outside the EU. You can also let your shipping company, logistics service provider or a customs agent do this for you. Based on your declaration, Dutch Customs will calculate the import or export duty.

Where can I find information about import procedures in the Netherlands?

The Dutch customs authority, Douane (part of the Belastingdienst), oversees import procedures. They provide an English-language website with detailed information on import duties, forms, and procedures: Dutch Customs - English. Submit an Import Declaration via the Automated Import System (AGS).

Can I import goods into the EU using a customs declaration?

You are then able to import the goods into the EU using a customs declaration. You will be required to pay the VAT on the goods to Customs. You will be able to deduct or claim refund of this VAT as input tax later on, if the goods are destined for you according to the customs declaration. The goods have then been imported under your name.

How do I ship my goods to the Netherlands?
