

# Enterprise ESS system cost breakdown in Brazil 2026

How did the external OEM enterprise storage systems market perform in 2024?

The external OEM enterprise storage systems (ESS) market reported annual growth of 3.6% in the fourth quarter of 2024, completing the year at 2.5% annual growth and \$33.5 billion in spending. Despite a recovery cycle after declines in 2023 the spending for the year was just \$100 million shy from the level of spending in 2022.

Will the external ESS market recover in 2025?

IDC expects that the recovery of the external ESS market will be pushed into 2025 as the strong growth in investments into computing infrastructure will start slowing down.
