

# Enterprise ESS system cost breakdown in Ireland 2026

Does Enterprise Ireland support large companies in 2022 VS 2021?

The number of large companies supported by Enterprise Ireland has continued to increase in 2022 versus 2021, and remains on track for reaching the 2030 target. The Department of Enterprise, Trade and Employment facilitated OECD led interviews and roundtables with a broad spectrum of stakeholders throughout during Q3 2023.

How many high potential start-ups will Enterprise Ireland support in 2023?

Enterprise Ireland has approved a total of 85 new High Potential Start Ups during 2023, against an end-of-2024 target of supporting 90 High Potential Start Ups. These start-ups span all sectors, with female founders involved in 26 projects and where 16 projects have a Sustainability/GreenTech focus.

How did Enterprise Ireland perform in 2022?

In 2022, Enterprise Ireland recorded the highest ever level of growth in export value, as exports increased by 19% to EUR32.1 billion, ahead of the Q4 2024 target of EUR30 billion. 2023 results are being captured in the Enterprise Ireland Annual Business Review survey during H1 2024.

What does the White Paper on Enterprise 2022-2030 mean for Ireland?

When the White Paper on Enterprise 2022-2030 was launched, it set Ireland on a clear and ambitious path towards achieving a thriving, sustainable, and resilient economy, which will deliver high-quality employment across the country.

Will the external ESS market recover in 2025?

IDC expects that the recovery of the external ESS market will be pushed into 2025 as the strong growth in investments into computing infrastructure will start slowing down.

What are the key competitiveness conditions for Irish enterprise?

In particular, infrastructure, the cost of doing business, skills and talent, access to finance, taxation, and regulation are identified as key competitiveness conditions for Irish enterprise.
