What is Bulgaria 2030 based on?

The document is based on the vision, goals and priorities of the National Development Programme BULGARIA 2030 approved by Decision No. 33 of the Council of Ministers of 20 January 2020.

Can the EU continue delivering funding to Bulgaria?

The EU can continue delivering funding to Bulgaria through the Green Innovation Programme. This support is mainly given through TC and is a part of Horizon 2020 - Climate Technology Innovation Support.

What is Bulgaria's policy for gas infrastructure development?

In the context of the European goals for building an interconnected and single pan-European gas market, Bulgaria's policy for gas infrastructure development is directly linked to the positioning of the country as one of the main gas distribution centres in South East and Central Europe.
