How will economic growth change in Serbia in 2024?

As a consequence, the expected volume of foreign trade would be reduced. Economic growth in Serbia would be lower by 1.7 pps in 2024 than in the baseline scenario, largely on account of reductions in export activity, investment and private consumption.
