

# Government procurement price of grid tied storage system in Croatia

Croatia will use 500 million euros (538 million dollars) from EU funds for the restructuring of the Croatian electricity grid and 80 million euros for battery storage.

The aid measure has been approved in favour of energy storage operator IE-Energy to partially finance the battery installations. Taking the form of a direct grant, the measure will cover approximately 30% of capital expenditures.
