How does smartepc differ from traditional EPC tendering models?

Here again, smartEPC differs from traditional EPC tendering models by privileging a main award criterion based on the Net Present Value (NPV) of all costs and benefits of the contract (energy savings, maintain & repairs costs, building value costs and/or benefits) that simplifies and facilitates the awarding of the contract.

What is the tendering phase of a smartepc contract?

In the tendering phase, the project team defines the final requirements of the EPC contract and consolidates the various project data within the set of standardized smartEPC tendering documents.
